### ARTICLE I NAME

The name of the corporation shall be:

**The name of the corporation is Centro Evangelístico Cruzando Fronteras of Orange & Osceola Counties, Inc.**

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- (A) This Corporation is a not-for-profit organization and it is organized as a church exclusively for charitable, religious, and education purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, chapels, radio stations, television station, rescue missions, day care centers, camps, nursing homes, and any other ministries that the Church may be led of God to establish.**
- (B) The Corporation (Church) shall also ordain and license men and women to the Gospel ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; educate believers in a manner consistent with the requirements of the Holy Scripture, both in Sunday and weekday schools of Christian education: ministry that the Church may decide, from time to time, to pursue in obedience to the will of God.**

### ARTICLE IV MANNER OF ELECTION

**An annual congregational meeting will be held in November each year. The primary purpose of the meeting is to receive and adopt the annual report, New Year's budget, and the elections of the officers and directors.**
