ARTICLE I CORPORATE NAME

The name of the corporation shall be: VICTIMS OF VIOLENT CRIMES SUPPORT CENTER, INC.

ARTICLE II TERM OF EXISTENCE

This Corporation is to exist perpetually.

ARTICLE III PURPOSE
