(A Non-Profit Corporation)**

**ARTICLE I
CORPORATE NAME**

The name of the corporation shall be:
VICTIMS OF VIOLENT CRIMES SUPPORT CENTER, INC.

**ARTICLE II
TERM OF EXISTENCE**

This Corporation is to exist perpetually.

**ARTICLE III
PURPOSE**

A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to provide victims of all violent crimes and their children individual crisis intervention, support groups, personal and judicial advocacy, referrals to mental health, legal aid, emergency food and financial services. Providing community and professional education.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations.

C. Provided, however, that the Corporation shall not engage in any action which is not permitted to be carried on by non-profit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit or be distributed to its members, directors, or officers.

**ARTICLE IV

The Corporation shall have a Board of Directors that shall consist of Voting Members. The method of election of voting members shall be stated in the Corporation's By Laws.

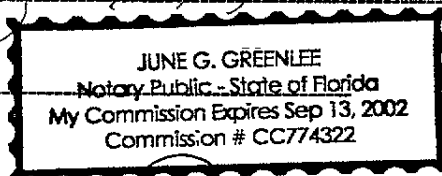
