Pursuant to the provisions of section 607, Florida Statutes, this Florida non-profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted: (indicate article number(s) being amended, added or deleted)

Article # 3 Purpose

These Articles of Incorporations are formed for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Article # 4 Manner of Elections of Directors

The manner in which directors are elected or appointed is by a majority vote to take place once a year in the month of April.

Article # 9 Distribution Upon Dissolution

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


