ARTICLE I

Name: The name for the corporation shall be FAMILY AND YOUTH COMMUNITY RESEARCH CENTER, INC.

ARTICLE II

Address: The principal place of business and mailing address for the corporation shall be 10750 SOUTHWEST 62 TERRACE, MIAMI, FLORIDA 33173.

ARTICLE III

Purposes: The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue tax law. The general nature and purpose of the activities to be promoted and carried on is to do any and all things hereinafter mentioned, as fully and to the same effect and extent as natural persons might or could do, viz:

- A. To develop and implement a multi-project approach to youth training and prevention/intervention services.
- B. To conduct research on critical issues of family processes, marginalization, health and health services.
- C. To foster exchanges and dialogues to strengthen culture and the arts.
- D. Pursuant to the laws of the State of Florida, to conduct and transact any and all lawful business.

ARTICLE IV

Directors: Except as otherwise provided by law, the entire voting power for the election of directors, and for all other purposes, shall be as stated in the bylaws. The corporation shall have four (4) Initial Directors. The names and addresses of the Initial Directors are:


ARTICLE V




