FIRST - NAME

That the name of this corporation shall be:

FLORIDA INFORMATION ENVIRONMENTAL RESEARCH, INC.

SECOND - LOCATION

The principal office of the corporation for the transaction of business is within Miami-Dade County, Florida, and the mailing address is 12800 S.W. 20<sup>th</sup> Terrace, Miami, Florida 33175

THIRD - OFFICE

The corporation designates 12800 S.W. 20<sup>th</sup> Terrace, Miami, Florida 33175, as its registered office and JESUS A. RAMOS, whose address is 12800 S.W. 20<sup>th</sup> Terrace, Miami, Florida 33175, as its registered agent, pursuant to Florida Statutes 607.034.

FOURTH - LENGTH

This corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

FIFTH - PURPOSE

A. Divulge amongst the Hispanic population of the United States the conservation of natural resources and preservation of the environment.

B. Research of tropical and sub-tropical plants for the conservation and preservation of natural resources.

SIXTH: FLORIDA

This corporation is organized pursuant to the Florida Statutes Chapter 617.

SEVENTH - DIRECTORS

The minimum number of directors of this corporation shall be Three (3) and the method of election is stated in the bylaws.

EIGHTH: ADDRESS OF FIRST DIRECTORS

NINTH - MEMBERS

The authorized number and qualifications of members of the corporation, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability to dues and assessments and the method of

collection thereof, shall be set forth in the bylaws. Election of directors shall be stated in the by-laws.

TENTH - NON-PROFIT

This corporation does not contemplate the distribution of gains, profits or dividends to members thereof, and is organized for

non-profit purposes; no part of any net earnings or assets thereof shall inure to the benefit of any member or any individual.

#### ELEVENTH - DISSOLUTION

In the event of dissolution of this corporation after paying or adequately providing for the debts or obligations of this corporation, the directors, or persons in charge of the liquidation, shall grant, convey, assign and transfer the remaining assets of this corporation unto:

(1) A state, a territory, a possession of the United States, or any political subdivision of any of the foregoing; or to the United States or District of Columbia, to be used exclusively for public purposes.

(2) A corporation or trust, community chest, fund or foundation:

(a) Created or organized in the United States or in any possession thereof, or under the laws of the United States, any state or territory, the District of Columbia or any possession of the United States; or

(b) Organized and operated exclusively for religious, charitable, scientific, literary or educational purpose.

(c) No part of the net earnings of which inures to the benefit of any private shareholder or individual; and

(d) No substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

The assets transferred to any organization listed above shall be used within the United States on any of its possessions, exclusively for the purposes specified in subparagraph (b).

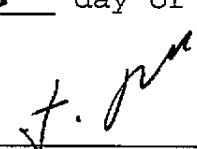
No such organization listed above shall qualify for distribution

unless such organization shall be an organization, association, or foundation organized and operated exclusively for charitable, religious, scientific or educational purposes which is tax-exempt, non-profit corporation under the United States Internal Revenue Code, and which is recognized as such by the United States Bureau of Internal Revenue.


If the corporation holds any assets in trust at the time of dissolution thereof, such assets shall; be disposed of in such a manner as may be directly by decree of the Superior Court in the county in which the dissolved corporation has its principal office, upon petition therefor by the Attorney General, or any person concerned in the liquidation.

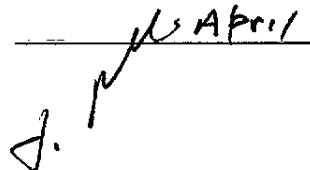
