**ARTICLES OF DISSOLUTION OF
BETHESDA LUTHERAN CITRUS COUNTY
ASSOCIATION FOR RETARDED CITIZENS, INC.**

Pursuant to the provisions of Section 617.1401, Florida Statutes, BETHESDA LUTHERAN CITRUS COUNTY ASSOCIATION FOR RETARDED CITIZENS, INC., a Florida not for profit corporation (the "Corporation"), adopts the following Articles of Dissolution for the purpose of dissolving:

- FIRST: The name of the corporation is BETHESDA LUTHERAN CITRUS COUNTY ASSOCIATION FOR RETARDED CITIZENS, INC.
- SECOND: The Articles of Incorporation were filed with the Florida Secretary of State on April 30, 2001.
- THIRD: The Corporation has not commenced to conduct its affairs.
- FOURTH: No debts of the Corporation remain unpaid.
- FIFTH: Dissolution was authorized by the sole member of the Corporation and by a majority of the Board of Directors of the Corporation on November 17, 2001. The number of votes cast for dissolution was sufficient for approval.
- SIXTH: The effective date and time of these Articles of Dissolution shall be the date and time filed with the Florida Secretary of State in accordance with Florida Statutes Chapter 617.
