The undersigned subscriber to these Articles of Incorporation is natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes.

### **ARTICLE I- NAME**

The name of the Corporation is **PARADISE FOR CHILDREN, INC.**, (hereinafter "Corporation").

### **ARTICLE II- PURPOSE OF CORPORATION**

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The program will consist of but shall not be limited to: Community Employment, Child Care, to reach and educate the masses of children, teens and adults, Youth tutoring Youth, Computer labs, and After School Care.

### **ARTICLE III- PROHIBITIONS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

#### **ARTICLE IV- DIRECTORS**

The Directors shall be elected by a majority vote of the Members of this Corporation. The Directors of the Corporation shall be:

The officers of the Corporation shall be:

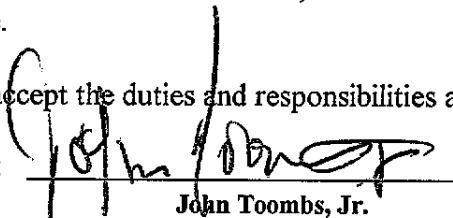

Members of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

## **ARTICLE XII - LIABILITIES FOR DEBTS**

Neither the members nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.

## **ARTICLE XIII - REGISTERED OFFICE AND REGISTERED AGENT**

The initial address of registered office of this Corporation is located at 1320 9<sup>th</sup> Street, West Palm Beach, Florida 33401-3132.

## **ARTICLE XIV - EFFECTIVE DATE**

These Articles of Incorporation shall be effective immediately upon approval of the Secretary of State, State of Florida.

## **ARTICLE XV - AMENDMENT**

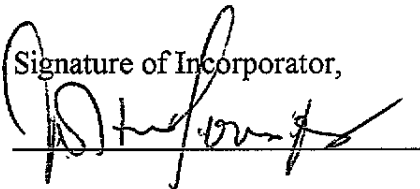

## **ARTICLE XVI - DISSOLUTION**

Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for public purpose.

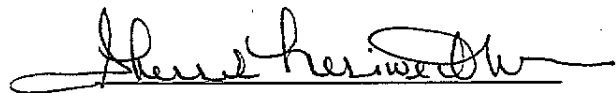
