The undersigned, a natural person competent to contract, hereby subscribe to these Articles of Incorporation for the purpose of forming a non profit corporation under the laws of the State of Florida.

ARTICLE I  
NAME OF CORPORATION

The name of this corporation is POWER PAWS K-9 CLUB, INC.

ARTICLE II  
PRINCIPAL OFFICE

The initial post office address of the principal office of this non profit corporation in the State of Florida is Post Office Box 22141, Fort Lauderdale, Florida 33335-2141. The Board of Directors may from time to time move its principal office to any other address in Florida.

ARTICLE III  
NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To promote public awareness of the Border Collie as a working breed, and provide a counseling or referral service for Border Collie owners.

To encourage Border Collie owner involvement in dog sport through public demonstrations and events.

To provide foster care and rehabilitation to endangered Border Collies.

To promote the spaying/neutering of companion Border Collies.

To provide training in obedience, agility, fly ball, frisbee and other dog activities for all breeds of dogs.
