We, the undersigned, acknowledge and file in the Office of the Secretary of the State of Florida, for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida, these Articles of Incorporation as by law provided.

ARTICLE I

Name

The name of the Corporation shall be **Revival Worship Ministries, Inc.**

ARTICLE II

Address

The principle place of business and mailing address of this corporation shall be **9927 Alvernon Drive, New Port Richey, Florida, 34655.**

ARTICLE III

Purpose

The purpose for which the corporation is organized shall be to operate exclusively for religious, charitable, and educational purposes as set forth in Section 501(c)3 of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes: To organize for religious purposes and to encourage and teach pastors and their congregations through evangelism and worship.

ARTICLE IV

Manner of Election

The manner in which the directors are elected or appointed shall be as follows: The Board of Directors shall initially be appointed by the President, and thereafter as a vacancy occurs, nomination and election by the majority shall fill such vacancy. Directors elected at the first annual meeting and at all times thereafter shall serve for a term of not less than one (1) year, and until the qualification of their successors in office. The Board of Directors may, in the Bylaws of the corporation or by separate resolution, provide for staggered terms of office. The number of Directors of this corporation shall not be less than three (3).
