ARTICLES OF INCORPORATION OF 01 APR 30 AM 10: 02 MAD 4 CHRIST, INC. TALLAHASSEE OF STATE OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- 1. The name of the Corporation is **MAD 4 CHRIST, INC.**
- 2. The principal place of business and mailing address of this corporation shall be:

- 3. The specific purpose for which the corporation is organized is to equip, encourage and instruct believers to make a difference for Christ right where God has placed them.
