**ARTICLES OF INCORPORATION OF
MAD 4 CHRIST, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

1. The name of the Corporation is **MAD 4 CHRIST, INC.**
2. The principal place of business and mailing address of this corporation shall be:

13830 SW 284 ST
Homestead, FL 33033.
3. The specific purpose for which the corporation is organized is to equip, encourage and instruct believers to make a difference for Christ right where God has placed them.
4. The manner in which the directors are elected or appointed is that the directors are appointed by the incorporator and thereafter the directors are elected pursuant to the Bylaws of the corporation.
5. The name and Florida address of the initial registered agent are:

6. This corporation is a nonprofit religious corporation and is not organized for the private gain of any person. It is organized exclusively for religious purposes under Section 501(c)(3) of the Internal Revenue Code.
7. No substantial part of the activities of this organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Internal Revenue Code, and the organization shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

8. The property of this corporation is irrevocably dedicated to religious purposes. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its directors, officers, members, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
9. Upon the dissolution of the organization, assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated for religious purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
