## Article I

The name of the corporation is Building Lasting And Caring Kinships through Collaboration, Advocacy, Faith, and Education Inc.

# Article II

# Article III

This corporation is organized exclusively for charitable, scientific, and educational purposes more specifically to the needs of indigent persons residing in the state of Florida.
