

ARTICLES OF INCORPORATION OF CONCERNED CITIZENS COALITION, INC.

(a Florida non-profit corporation)



ARTICLE I. NAME

The name of this corporation shall be CONCERNED CITIZENS COALITION, INC., a Florida non-profit corporation.

ARTICLE II. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE III. NATURE OF BUSINESS

The general nature of the businesses to be transacted by this corporation is to protect the interest of the residents of Sewalls Point and Martin County for environmental issues and any other lawful business.


