**Name** 

The name of this corporation is The Bill and Martha Pullum Family Foundation, Inc.

-ARTICLE II.

## **Duration**

The duration of this Corporation shall be perpetual, commencing with the filing of these Articles with the Department of State of the State of Florida. In the event of dissolution, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 (the "Code") or corresponding sections of any prior or future Internal Revenue Code, or to the federal, state or local government for exclusively public purposes.

## ARTICLE III.
