**ARTICLES OF INCORPORATION OF
THE BILL AND MARTHA PULLUM FAMILY FOUNDATION, INC.**

A FLORIDA NONPROFIT CORPORATION

ARTICLE I.

Name

The name of this corporation is The Bill and Martha Pullum Family Foundation, Inc.

ARTICLE II.

Duration

The duration of this Corporation shall be perpetual, commencing with the filing of these Articles with the Department of State of the State of Florida. In the event of dissolution, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 (the "Code") or corresponding sections of any prior or future Internal Revenue Code, or to the federal, state or local government for exclusively public purposes.

ARTICLE III.

Purposes

The primary purpose for which this Corporation is organized is to support the education, development, and physical well-being of children of all backgrounds and their families. The Corporation may undertake any action necessary to further this general purpose including, without limiting the generality of the foregoing, make research or other grants to charitable organizations, establish scholarships, develop educational programs and materials, and otherwise support organizations sharing goals consistent with the general purposes expressed herein.
