# QUEEN'S HIGH SCHOOL ALUMNI ASSOCIATION, (FLORIDA CHAPTER) INC.

We the undersigned hereby associate ourselves together for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, as amended from time to time, and certify as follows:

# ARTICLE I: NAME

The name of this not-for-profit corporation shall be QUEEN'S HIGH SCHOOL ALUMNI ASSOCIATION, (FLORIDA CHAPTER) INC. (the "Corporation").

#### ARTICLE II: PRINCIPAL OFFICE

The initial principal office of the Corporation shall be 7125 Glenwood Drive, Boynton Beach, Florida 33436 or at such other place as shall be designated by a majority of the members of the Board of Directors. The mailing address of the Corporation shall be P.O. Box 3991, Boynton Beach, FL. 33424. The Corporation may also have a registered office and other offices at such other places as the Board of Directors may appoint.

#### ARTICLE III: PURPOSE

The purpose for which this Corporation is organized is to (a) assist in the education of students by means of mentoring, providing financial assistance, providing learning materials such as stationary, books, etc., and providing any upgrades or projects thereof for the maintenance of the school being attended by the students; and to (b) engage in any lawful act or activity for which corporations not for profit may be organized under Chapter 617, Florida Statutes.

#### **ARTICLE IV: MANNER OF ELECTION OF OFFICERS**

The affairs of the Corporation shall be managed by the Board of Directors which shall elect a President, Vice President, Secretary and Treasurer. The officers shall be elected by the Board of Directors at the Monthly Meetings to serve for six months, until their successors are elected and qualify.

### ARTICLE V. MANNER OF ELECTION OF DIRECTORS

Directors of the Corporation shall be elected at the annual meeting of the membership. The Board of Directors shall consist of not less than three directors, the exact number of directors to be determined in accordance with the By-Laws of the Corporation.
