# ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

### ARTICLE ONE

The name of the corporation is HELP CHILDREN IN BANGLADESH, INC.. The principle address of the corporation is: 15084 Jog Rd., #13, Delray Beach, FL 33446.

### ARTICLE TWO

The mailing address of this corporation shall be: 15084 Jog Rd., #13, Delray Beach, FL 33446.

### ARTICLE THREE

The purpose for which the corporation is organized is that of a charitable organization which shall provide the following assistance:

- 1) Educational programs for children of Bangladesh;
- 2) Free medical programs for children of Bangladesh;
- 3) Food assistance for children of Bangladesh;
- 4) Programs to encourage the end of child labor in Bangladesh;
- 5) Housing programs for homeless children in Bangladesh;
- 6) Programs to end child abuse in Bangladesh;
- 7) Educational scholarship and grant programs for children of Bangladesh;
- 8) Financial support programs for poor families;
- 9) Education and support programs for assist families in becoming self-dependent;

#### ARTICLE FOUR

The manner in which the directors are elected or appointed is described in the by-laws of the corporation.


#### ARTICLE FIVE


