**ARTICLES OF INCORPORATION:** The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following articles of incorporation.

**ARTICLE I: NAME**

The name of this organization shall be " Florida Citizens For A Just Society, Inc."

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
Florida Citizens For A Just Society, Inc., 7858 Havana Highway, Havana, Florida 32333.

**ARTICLE III: PURPOSES**

The Florida Citizens For A Just Society, Inc. is organized as an education, training and communications entity, to develop and implement a statewide organization dedicated to assuring the citizens of the State of Florida that justice will prevail in all levels of government. Research, training and utilization of high technical tools such as the information superhighway, the internet, and newspapers, newsletters and electronic media which shall be open to all, regardless of race, religion, sex, national origin, age, religion, economic capability or disability. It is especially geared to the underrepresented to assist them in improving their skills in understanding government, and helping them learn how to make their voices heard using technology of the future and the internet, helping them to meet their potential and surpass it.

**ARTICLE IV: MANNER OF ELECTION OF DIRECTORS AND LEGAL STATUS**

Directors are elected to the Board of Directors and Officers chosen at the annual membership meeting held each year through a nominating and election process. Membership in the organization shall be open to any individual, non-profit-organization, family or corporation. Non-members may participate in the utilization of the technical equipment and also volunteer their services to assist students in acquiring knowledge about justice in this country. All members may participate in activities without regard to race, sex, national origin or religion, economic capability or disability. Membership dues shall be set by the Board of Directors. The Florida Citizens For A Just Society, Inc., shall be a tax exempt, tax deductible organization under the terms of Section 501(c) (3) of the United States Internal Revenue Code of 1954 ( or any corresponding provision of any future Internal Revenue Code)

organized for the pursuit of education, training and communication.. Monies generated through the efforts of this group shall not inure to the benefit of its members trustees, officers or any other private persons.
