**ARTICLES OF INCORPORATION
OF

We, the undersigned with other persons being desirous of forming a corporation for charitable and philanthropic purpose under the provision of Ch. 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be: **MAUDY BROWN FAITH OUTREACH MINISTRY, INC.**, and the initial principal address of the corporation is: **194 NE 33RD STREET, OAKLAND PARK, FL 33334.**

ARTICLE II

Notwithstanding any other provision of these articles, the purpose for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational, with in the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding provision of the future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from the Federal Income tax under Section 501(c)(3) of the present Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and make payments and distributions in furtherance of Section 501(c)(3) purpose. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

This corporation shall be to promote the spiritual and intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, personal and mixed, all donations, gifts, grants, legacies, privileges and immunities whatsoever which may appertain or belong to said church for its use, to have and to hold the same for proper use and behoof of the said church and to be invested with all rights of the corporation not for profit under the laws of the State of Florida. In addition thereof, the object of the corporation is to conduct religious worship and instruction, churches, schools, pastoriums, and other institutions connected therewith of a religious education, charitable and benevolent character to the end that its own members and other may be generally instructed and guided concerning those Articles of Faith which are most surely held among Church of God churches and to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; to promote home and foreign missions and to aid in the spread of the Gospel of Jesus Christ to the end of the earth; also to educate, prepare and ordain Christian men and women for the ministry of of the Gospel of Jesus Christ.

ARTICLE III

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE IV

The qualification for members and the manner of their admission is to be provided for in the Bylaws.

ARTICLE V

The street address and city of initial registered office of the corporation is: **1445 NW 6TH AVENUE, Ft. Lauderdale, FL 33311**, and the name of the registered agent at such address is **MAUDY BROWN**.

ARTICLE VI

The members of the Board of Directors shall be elected and hold office in accordance with the Bylaws. Members of this corporation may provide such bylaws for the conduct of its business and the carrying out of its purpose as they deem from time to time.


