AMENDMENTS TO ARTICLES OF INCORPORATION MAUDY BROWN FAITH OUTREACH MINISTRY, INC.

The following amendments are made to the Articles of Incorporation:

We, the undersigned with other persons being desirous of forming a corporation for charitable purpose under the provision of Ch. 617 of the Florida Statutes, do agree to the following:

ARTICLE II

The corporation is organized exclusively for charitable, educational, religious or scientific purpose, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

ARTICLE III

No part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions and furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or cherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of of the Internal Revenue Code(or corresponding section of any future Federal tax code.)
