

- 2.Expand the existing pool of trained amateur radio operators, technicians, and electronics experts by providing education, training opportunities, and licensing examinations.
- 3.Educate and inform the public about the benefits associated with the amateur radio service.
- 4.Educate the general public through SKYWARN weather training programs to foster public safety and awareness of amateur radio's benefits to the community by providing and assisting in providing emergency communications services for the benefit of the public.
- 5. Foster emergency preparedness among amateur radio operators in West-Central Florida by establishing and maintain an amateur radio repeater for use in the SKYWARN weather spotting network for the National Weather Service as well as cooperative emergency preparedness efforts with local, state, and federal emergency services and disaster responders.
- 6.Establish and maintain an emergency backup communications repeater system to support the Police and Fire Departments of the Hernando County, Florida, and surrounding areas, in the case of primary system failure.
- 7. Provide amateur radio operators in West-Central Florida with opportunities for education, training, fellowship, operating, and contesting in order to maintain a high level of preparedness, teamwork, and technological expertise to further benefit the public in the event of emergencies.

Article IV (The original Article IV shall now be Article VI)

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article V

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Hernando County, Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article I

FOREN PHOSE The name of the corporation shall be Spring Hill Amateur Radio Club

Article II

The principal place of business is designated by the president of the organization. At the time filing for incorporation, the principal place of business is the High point Club House meeting hall, located on Eagle Nest Dr., in the High point Subdivision of Hernando County Florida.

Article III

The Spring Hill Amateur exchange of information an radio knowledge by teachin the purpose of obtaining an
