## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FAIRWAY ISLES AT BAYSIDE LAKES HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, Fla. Stat., FAIRWAY ISLES ATERAL LAKES HOMEOWNERS ASSOCIATION, INC. ("Association") adopts the following Amendment to its Articles of Incorporation.

FIRST: Amendment adopted:

Article 6 of the ARTICLES OF INCORPORATION OF FAIRWAY ISLES AT BAY SIDE LAKES HOMEOWNERS ASSOCIATION, INC. is/are hereby amended as follows (additions are indicated by <u>underlining</u>; deletions are indicated by <u>strike-outs</u>, omitted and unaltered provisions are indicated by ellipses):

## ARTICLE 6 EXISTENCE AND DURATION

- 6.01 Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.
- 6.02 In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution, or liquidation.

THIRD: Adoption of Amendment:

Article 13 of the ARTICLES OF INCORPORATION OF FAIRWAY ISLES AT BAYSIDE LAKES HOMEOWNERS ASSOCIATION, INC., entitled "AMENDMENTS", in effect prior to the adoption of the instant amendment, provided that Amendments to the Articles of Incorporation must be approved by an affirmative vote of members holding at least a two-thirds (2/3) vote of the total number of members of the Association entitled to vote thereon.
