*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

**ARTICLE I - NAME**

The name of the corporation shall be: GRACE INTERNATIONAL OUTREACH MINISTRIES, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 13950 Monticello, Davie, Florida 33325

**ARTICLE III - PURPOSE(S)**

The specific purpose(s) for which the corporation is organized is (are):

Support to missionary families. Planting new churches in remote areas.
