BOARD OF TRUSTEES. THE SEAL MAY BE USED CUASING IT OR A FACSIMILE THEREOF TO BE
IMPRESSED OR AFFIXED OR IN ANY MANNER REPRODUCED. TO SUBSTITUTE THE SEAL, THE WORD,
"ATTEST" OVER THE SIGNATURE OF THE CHURCH ADMINISTRATOR OR (SECRETATRY) MAY BE USED.
