ATTACHMENT TO ARTICLES OF INCORPORATION OF ROYAL PALM BEACH YOUTH SOFTBALL ASSOCIATION, INC.

ARTICLE III PURPOSE: This Corporation shall be a nonprofit corporation. The purposes for which Royal Palm Beach Youth Softball Association, Inc. is organized are exclusively to foster national amateur sports competition within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
