The undersigned, being citizens of the United States, desiring to form a Non-Profit Corporation acting as Incorporators of a not for profit corporation pursuant to chapter 617, Florida Statutes adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: BAPTIST CHURCH PLANT 2001, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business shall be located in the <u>City of St. Petersburg</u>, <u>Pinellas County</u>.

The street address and mailing address of this corporation shall be 7400 21st Street North, St. Petersburg, Florida 33732-6171.

ARTICLE III PURPOSE

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
