The undersigned, for the purposes of forming a corporation under the Florida Business Corporation Act, do hereby make and adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of this corporation shall is YOUNG CHRISTIANS TAKING OVER, INC., (hereinafter referred to as the "Corporation").

**ARTICLE TWO
PRINCIPAL OFFICE**

**ARTICLE THREE
DURATION**

The duration of the Corporation shall be perpetual.

**ARTICLE FOUR
PURPOSES**

The Bylaws of the Corporation are to be made and adopted by the Board of Directors, and may be altered, amended or rescinded by the Board of Directors.

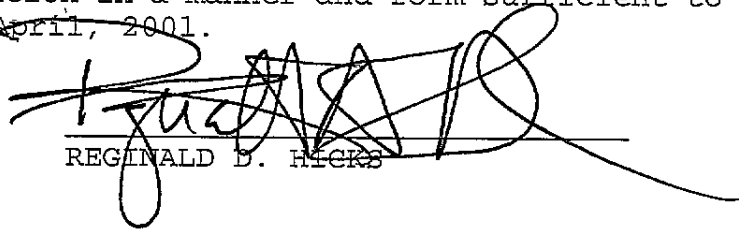
**ARTICLE ELEVEN

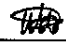
