#### ARTICLES OF INCORPORATION

## SAFARI WILDLIFE FUND, INC.

THE UNDERSIGNED, acting as Incorporator of a corporation under the Florida General Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation.

## ARTICLE I - NAME AND CORPORATE ADDRESS

The name and address of this Corporation is:

SAFARI WILDLIFE FUND, INC. 119 Clipper Lane Jupiter, Florida 33477

### ARTICLE II - DURATION

The duration of this Corporation is perpetual.

## ARTICLE III - PURPOSE

The purpose for which this Corporation is formed is to engage exclusively in charitable purposes, and no part of the net earnings shall inure to the benefit of any private shareholder or individual. This Corporation shall not engage in any activity which could be considered as propaganda or otherwise attempting to influence legislation or participate in or intervene in any political campaign on behalf of any candidate for public office.

This Corporation is specifically formed to provide financial support for the preservation of all wildlife, wherever located, and for the support of those individuals that the Corporation determines have made a significant contribution to the furtherance of the preservation of wildlife. In this regard it will seek to develop practices and patterns for the protection of wildlife, with

emphasis on the preservation of local habitats for the wildlife; promote the creation of environmentally sound tourist attractions; preservation of historic and other structures; and make distribution of charitable goods and medical supplies, where necessary.

# ARTICLE IV -MEMBERS

The initial members of the Corporation and their addresses are as follows:

Membership in the Corporation may be terminated by a majority vote of the Directors of the Corporation. Membership may not be transferred without the consent of the Directors.

#### ARTICLE V - AMENDMENT

The Articles of Incorporation may be amended, altered, changed, or repealed by the affirmative vote of a majority of the Directors.

#### ARTICLE VI -DISTRIBUTION OF ASSETS

Upon dissolution of final liquidation of the Corporation its assets shall be distributed to an organization that is a recognized charitable corporation under the provisions of Section 501(c)(3) of the Internal Revenue Code, or to an agency of the State of Florida or the United States of America that is engaged in tax exempt functions.
