The undersigned incorporators, being competent to contract, subscribe to these Articles of Incorporation to form a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

#### <u>ARTICLE I – NAME</u>

The name of the corporation shall be: Goodwill Academy, Inc.

#### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

# ARTICLE III – PURPOSE(S)

This Corporation may, and is authorized to, engage in any not-for-profit activity or business under the laws of the United States of America and the State of Florida, and specifically to offer support services to parents educating their children through homeschooling. Specifically, providing record keeping of grades and transcripts, certified teachers to review portfolios, workshops, seminars, tutoring, field trips, summer camps, standardized testing, and any other service that may help parents of homeschoolers to best educate their children.

The board of directors may authorize and require the payment of reasonable expenses incurred by directors attending meetings of the directors.

- D. Nothing in this article shall be construed to preclude the directors from serving this corporation in any other capacity and receiving compensation therefrom.
