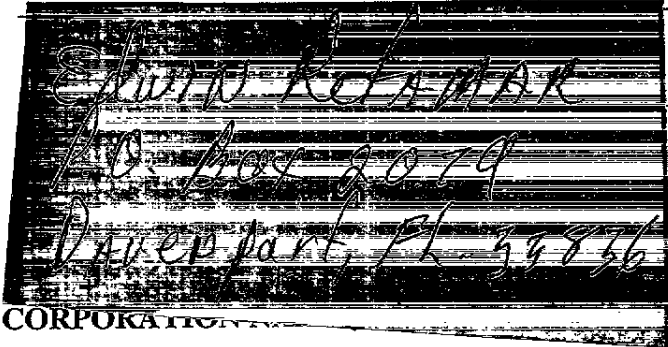

FOUNDATION ON THE ROCK OF PEACE CHURCH, INC. hereby forms a religious corporation not for profit in accordance with the provisions of Chapter 617, Florida statutes, and all amendments relating thereto and hereby adopts the following articles of incorporation:

ARTICLE I

THE NAME AND ADDRESS

The name of the corporation is **FOUDATION ON THE ROCK OF PEACE CHURCH, INC.** with a physical address at 203 W Bay St. Davenport, FL. 33837

ARTICLE II

PURPOSE
