Notwithstanding any other provision of these articles, this corporation shall not carry on any activities deemed impermissible for corporations exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1896 or the corresponding provision of any future United States Internal Revenue law or by a corporation, contributions to which are deductible under section 170 (c) (2) or the corresponding provision of any future United States Internal Revenue law. On the dissolution of this corporation the board of directors shall dispose of all assets of this corporation to organizations that are organized and operated exclusively as exempt organizations under Section(s) 501 (c) (3) of the Internal Revenues Code of 1986 or the corresponding provision of any future United States internal revenue law, or after paying or making provisions for the liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is located. Such court of competent jurisdiction shall dispose of the assets of this corporation to organizations that are organized and operated exclusively for charitable, educational, or scientific purposes.
