## ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

### ARTICLE I NAME

The name of the corporation shall be:

FAMILIES FIGHTING NEUROBLASTOMA, INC.

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

The initial purpose of the corporation is to fund 75% to a specific patient fighting Neuroblastoma and the remaining 25% for Neuroblastoma Research. Thereafter, the corporation will fund 100% to Neuroblastoma Research by receiveing donations from public and private sources through fund raisers benefiting families fighting Neuroblastoma, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for Neuroblastoma Research at Memorial Sloan - Kettering Hospital, c/o Dr. Cheung either directly or by contributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501 (c)(3) of the Internal Revenue Code of 1954 and its Regulations as they now exist or as they may hereafter be amended, or by an organization contributions to which are deductible under Section 170 (c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.
