ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

OF

PAMILIES FIGHTING MEUROBLASTON, INC.



- 1. The name of the corporation is Families Fighting Neuroblastoma, Inc., a Florida not for profit corporation. (the "Corporation").
- 2. Article III of the Articles of Incorporation of the Corporation is revised to add the following at the end of Article III: "Neuroblastoma patients will be eligible for assistance after submitting an application to the board for consideration. All references to a specific patient's name will be deleted from the application in order to insure against any appearances of favoritism. The governing board will select up to three (3) patients diagnosed with neuroblastoma in any given year to receive financial assistance, in an amount at the discretion of the governing board. The total amount of assistance given in any given year will not exceed 75% of monetary funds donated to the corporation in any given year."

"The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law."

"In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or the corresponding sections of any prior or future Internal Revenue Code, or to the Federal. State, or local government for exclusive public purpose."

- 3. This Amendment was recommended by the Board of Directors of the Corporation on February 14, 2002.
- 4. This Amendment was approved by a majority of Corporation's members entitled to vote, and the number of votes in favor of the Amendment was sufficient for approval.
