**ARTICLES OF INCORPORATION  
FOR  
SANLANDO COMMUNITY FOUNDATION, INC.**

In Compliance with Chapter 617, F.S., (Not for Profit)

***ARTICLE I - NAME***

The name of the corporation shall be: Sanlando Community Foundation, Inc.

***ARTICLE II - PRINCIPAL OFFICE***

The principal office and mailing address of this corporation shall be:

1939 Boothe Circle  
Longwood, Florida 32750-6774

***ARTICLE III - PURPOSE***

The purpose for which this corporation is organized is to establish and maintain a charitable foundation to promote and benefit the programs and services of the Corporation and other nonprofit organizations primarily within or in the vicinity of the county of Seminole, State of Florida, and also in other locales as needs arise; and to advance other charitable work; and to take, buy, manage, hold, sell, and dispose of the property, both real and personal, of this Corporation, subject to such rules and regulations, if any, as the Corporation may adopt. The purposes of the Corporation shall be exclusively charitable, religious, and educational. The Corporation is not formed for pecuniary or financial gain, and no part of the assets, income, or profit of the Corporation is distributable to, or inures to the benefit of its directors or officers except to the extent permitted under the Florida Not For Profit Corporation Act. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

***ARTICLE IV - MANNER OF ELECTION***

The manner in which the Directors are elected or appointed is:

1. The Board of Directors shall consist of the President, the Executive Director of the Corporation (but who shall not have voting rights), at least one (1) lay person who is also a member of the Leadership Council of Sanlando United Methodist Church, and such other individuals duly elected first by the approval of Leadership Council on April 22, 2001, and then thereafter by the annual Charge/Charge Conference of Sanlando United Methodist Church (or as

otherwise provided for the election of officers in Article V herein), with their term of office ending on the final day of the Sanlando United Methodist Church leadership year for which they were nominated.

The Board of Directors shall consist of not less than eleven (11) members. The members of the Board of Directors shall serve until the election and qualification of their successors.

2. A majority of the Board of Directors shall at all times consist of members of Sanlando United Methodist Church.
