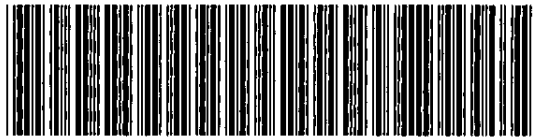

## **ARTICLE EIGHT-ADMMENDMENTS**

### **Pastoral Role**

The Pastor is the spiritual leader of the Church. The Senior Pastor is an Ordained Minister with the necessary training and experience to lead the church to spiritual growth. As a leader of the church he is granted voice and vote in the Board of Trustees and is also an ex-officio member of all committees of the Church. The Board of Trustees or any committee will not take any action without the participation, counsel and opinion of the Senior Pastor, who will also have power to veto, if needed in any resolution which he considers not acceptable. The Senior Pastor is called to serve the Lord as a servant of God. The Church will discern with spiritual wisdom the calling and once the pastor has been call and appointed, the Church will work in agreement and submission to the authority invested by God to the Servant of God. The Senior Pastor's position is considered a tenure position from the time he is called and appointed. If the Senior Pastor resigns or retires, he will have the opportunity to be designated "Pastor Emeritus" and will continue to serve providing counsel and guidance to the Board. At the time of his leaving, the Senior Pastor will have the opportunity to designate his successor in counsel with the Board. The Senior Pastor as the spiritual leader of the Church has inherent the responsibility to discipline any member of the church including any officials, staff or leaders of the church. The disciplinary process will be defined in the By-Laws. The Pastor as the spiritual leader needs to teach by his example. As an ordained minister the Senior Pastor, needs to keep a standard of good moral character. When at the judgment of the majority of the Board members the Senior Pastor commits immoral conduct incompatible with the character of ministerial office, grounds for probable cause to start a disciplinary process could be determined in a confidential manner. The Board will try to mediate and resolve any minor situation, before taken to the Church. If two thirds of the Board members consider it is a serious matter, disciplinary action can be determined by the Board of Trustees. The Senior Pastor will not be sanctioned or removed from his position without just cause, without following proper due process and without the approval of two thirds of the vote of the Board of Trustees. Immoral conduct incompatible with the character of the ministerial office is grounds for discipline of ordained ministers. The guidelines to define and describe kinds of behavior which are incompatible with the character of the ministerial office, to define just cause and the disciplinary due process will be included in the By-Laws and will not contravene the principles established in this article.
