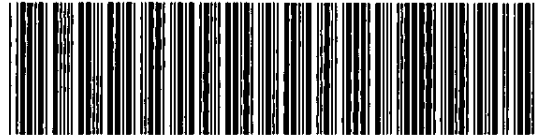

## **ARTICLE XI – ADMENMENT MEETINGS**

- A. The church will only have one annual meeting set apart on the Wednesday night following the first Sunday. To receive reports only by the pastor who will inform the church of all programs and activities, request for letters of dismission, and for the transaction of such other business as it may be proper.
- B. The annual business meeting of the membership of the church shall be held on the Wednesday following the Sunday in September of each year, at which meeting, the annual report shall be read.
- C. All heads of departments, such as Sunday School Director, Training Union Director shall be elected at the annual meeting by the recommendation of the pastor.
- D. Deacons and other church officers “except the pastor” shall be elected at the annual meeting in September of each year by the recommendation of the pastor.
