**ARTICLES OF INCORPORATION OF
Asian Christian Aviation Ministries, Inc.**

A NOT FOR PROFIT CORPORATION

We the undersigned do hereby join together in the formation of a non-profit corporation, following the terms and conditions, to wit:

ARTICLE I

The corporation will be entitled 'ASIAN CHRISTIAN AVIATION MINISTRIES, INC., having it's principal place of business located at 46225 Firestone Rd., Jacksonville, Florida 32210, and a mailing address of P.O. Box 14175, Jacksonville, Florida 32238.

ARTICLE II

This corporation is a non-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the purpose of private gain of any person. The specific purpose of this corporation is to provide community outreach and relief services for the poor and disenfranchised persons of rural areas internationally. The organizations purposes are solely charitable, educational or religious in nature and are in accordance with the Internal Revenue Service Code 501(c)(3).

ARTICLE III

This corporation will not own any capital stock and the corporations operation is under perpetual terms.

ARTICLE IV

Upon dissolution any and all assets will be distributed for exempt purposes according to the conditions set forth in the Internal Revenue Service Code 501(c)(3).

ARTICLE V

A Board of Directors shall manage the affairs of the corporation. The number of directors constituting the entire board will be arranged in the manner as set forth in the organization's by-laws, but under no circumstance shall the board consist of less than (3) members.

ARTICLE VI

All meetings of the board members will be held in accordance with the organization's by-laws.

ARTICLE VII

The books of the corporation may be kept subject to any provisions contained within or outside of the statutes of the State of Florida, at such a place so designated by the Board of Directors.

ARTICLE VIII

The name of the officers who shall hold office until the corporation shall elect said officers to succeed present officers according to the provisions as set forth in the by-laws are as follows:
