ARTICLE I NAME

The name of the corporation is Panama City Free Clinic, Inc. and is incorporated pursuant to Chapter 617.0202, Florida Statutes, as a not for profit corporation.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be:

ARTICLE III PURPOSE

The specific purposes of this corporation is to promote health and wellness by providing quality health services and medications, at no charge, to individuals without access to basic health care.

ARTICLES IV MANNER OF ELECTION

The qualification and manner in which membership is attained, directors are elected or appointed and dismissed are covered in the by-laws of this corporation.

ARTICLES V TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLES VI TERMS OF DISSOLUTION

In the event of dissolution of this corporation, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local government for exclusive public purpose.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law or (b) a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States.

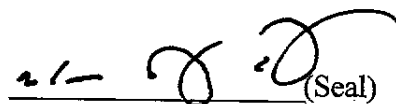

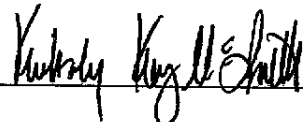
