ARTICLE III PURPOSE: This Corporation shall be a nonprofit corporation. The purposes for which Cruisers For Kids, Inc. is organized are exclusively charitable within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
