ARTICLES OF INCORPORATION

OF

IN COMPLIANCE WITH CHAPTER 617, F.S. (Not for Profit)  
Organized under I.R.S. Code Sec. 501(c) (3)

ARTICLE I - NAME

The name of this corporation is Abundant Life Christian Center Melbourne, Inc. and is located at 133 Coral Way East, Indialantic, FL 32903.

ARTICLE II - DURATION

This corporation shall have a perpetual existence commencing upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

The nature of the business or purposes to be conducted or promoted are: To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida and Chapter 617 F.S. (Not for Profit), specifically a qualified religious organization.

ARTICLE IV - MANNER OF ELECTION

Except as otherwise provided by law, the entire voting power for the election of directors, and for all other purposes, shall be vested exclusively in the hands of the incorporator.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

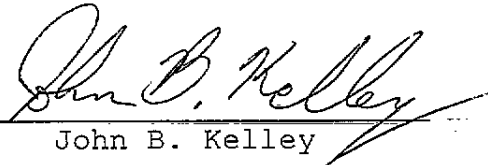
ARTICLE VIIII - AMENDMENT

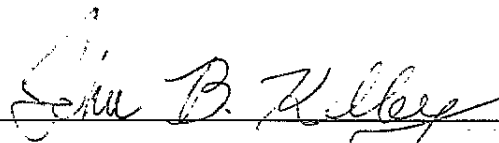
