ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: NAME

THE NAME OF THE ORGANIZATION WILL BE:

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

NSBE-AE WILL STRIVE TO BUILD A BRIDGE BETWEEN STUDENTS, ALUMNI, INDUSTRY, AND ACADEMIA.

ARTICLE IV: MANNER OF ELECTION
