ARTICLE I - NAME

The name of the corporation shall be:

Sarasota Youth Dance Alliance, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The corporation is organized and operated exclusively for charitable purposes to foster and provide opportunities to local dancers to compete in national amateur dance competitions within the meaning of section 501(c)(3) of the Internal Revenue Code. Including, for such purposes, the making of distributions to organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV - MANNER OF ELECTION

ARTICLE VI - MANNER OF OPERATIONS

Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not furtherance of the purposes of the corporation. No part of net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE VII - DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VIII - FISCAL YEAR
