

ARTICLE 1. NAME

The name of the Corporation is: **Women of Choice Community Center, Inc.**

The principal place of business is: **1718 N. W. 38th Avenue, Ft. Lauderdale, FL 33311**

ARTICLE 2. PURPOSE

The purposes for which this corporation is organized are exclusively charitable and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States of Internal Revenue Law.

This organization is a not-for-profit Corporation and is not organized for the private gain of any person. It is organized under the non-profit Public Benefit Corporation Law for charitable purposes.

ARTICLE 3. SPECIFIC PURPOSE/S

The specific purposes of this corporation are: To provide charitable community outreach services to At-Risk Females 13 thru 17 years of age.

To provide educational awareness and drop out prevention, emphasizing their choice to say no to: premarital sex, drug, alcohol and violence.

To provide after school tutoring and incentives to promote higher education goals.

To receive donations, gifts, grants and bequests in order to promote the purposes of the corporation.

To exercise all rights and powers conferred by the laws of the State of Florida upon Non-Profit Public Charities.

ARTICLE 4. REGISTERED AGENT

ARTICLE 5. OFFICERS

The officers of the Corporation shall consist of a President, Vice President, Secretary and Treasurer. Each shall be elected by the Board of Directors, and may be removed by the Board of Directors at such time and in such manner as may be prescribed in the Bylaws. The initial officers were appointed by the President

ARTICLE 6. ORGANIZATION

A. This Corporation is organized and operated exclusively for charitable and educational purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

C. No substantial part of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE 7. CORPORATE ASSETS

Upon the dissolution of the corporation, assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes, and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

ARTICLE 8. DIRECTORS

The initial Board of Directors will consist of eight (8) Directors. The number of directors may be increased or decreased by amendment of the Bylaws, but, shall never be less than five.

The initial Directors of the Board were appointed by the President, for the term of two (2) years. Directors may be re-elected and additional Directors elected at the first annual meeting.

ARTICLE 9. NON-MEMBERSHIP



ARTICLE 11. STOCK


This corporation is organized under a **Non-Stock Basis**.
