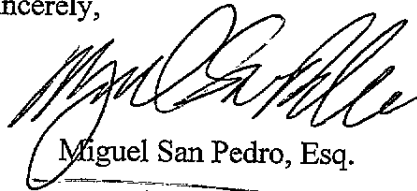

ARTICLES OF INCORPORATION OF Pro Monument Tony Izquierdo,
A Corporation Not For Profit and the initial principle address of
the corporation is: 1100 E. 10th Avenue, Hialeah, Florida 33010

The undersigned, for the purpose of forming a nonprofit
corporation under the laws of the State of Florida, do hereby make
and adopt the following Articles of Incorporation:

ARTICLE 1

NAME

The name of the Corporation is:

PRO MONUMENT TONY IZQUIERDO, INC., A CORPORATION NOT FOR PROFIT

ARTICLE 2

NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of
the State of Florida. The Corporation is not formed for pecuniary
profit. No part of the income or assets of the Corporation is
distributable to or for the benefit of its Members,
Trustees or Officers, except to the extent permissible under law.

ARTICLE 3

DURATION

The duration (term) of the Corporation is perpetual.

ARTICLE 4

PURPOSES

The Corporation is organized, and shall be operated
exclusively for, the following purposes:

To do any and all charitable activity permitted under the
State of Florida in accordance with any and all applicable Internal
Revenue Regulations that permit the raising of revenue by tax
exempt non for profit corporations.

To exercise all rights and powers conferred by the laws of the
State of Florida upon nonprofit corporations including without
limiting the generality of the foregoing, to acquire be bequest,
devise, gift, purchase, lease or otherwise any property of any sort

or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property, for any of the purposes set forth herein.

To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE 5

LIMITATION

No part of the net earnings of the Corporation shall insure the benefit of or be distributable to its Members, Trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 4 (Purposes) hereof.

ARTICLE 6

INCORPORATORS AND

INITIAL BOARD OF TRUSTEES/DIRECTORS

The management of the corporation shall be vested in the Board of Trustees. The initial number of members of the Board of Trustees shall be Three. The Number of members of the Board of Trustees may be Changed in accord with the Laws Of The State Of Florida and The By Laws of the Corporation. The voting Members shall elect the Trustees annually. The Names and Addresses of the initial board of Trustees is as follows.
