The undersigned, for the purpose of forming a Corporation under the Florida General Act hereby files the following Articles of Incorporation pursuant to Section 607.0202 of the Florida Statutes:

**ARTICLE I
NAME**

The name of the Corporation shall be **FUNDACION HOGAR DE LUZ Y AMOR, INC.** approved by the board of directors. The principal place of business shall be 112 Essex Ave, Altamonte Springs, FL 32701.

**ARTICLE II
TERM**

The term of the Corporation is perpetual.

**ARTICLE III
PURPOSE**

The purposes for which the Corporation is organized is for the worshiping of the Christian religion and practices and all other activities necessary to carry out the function of the Corporation, to engage in any activities and to transact any and all lawful business for which the Corporation may be incorporated under the Florida General Corporation Act and/or permitted under the laws of the United States, doing business as **FUNDACION HOGAR DE LUZ Y AMOR, INC.**

**ARTICLE IV

No stocks are issued for non-profit corporations.
