### ARTICLES OF INCORPORATION

### ARTICLE VIII DIRECTORS

A. Numbers and Qualifications. The affairs of the Association shall be managed by a Board of not less than three (3) nor more than nine (9) directors (the "Board"), who need not shall all be Members of the Association. The By-Laws may provide for any additional eligibility requirements of the members of the Board. The first Board shall be comprised of three (3) persons.
