ARTICLE I NAME

The name of the corporation shall be:

PEOPLE SERVICES OUTREACH INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. This corporation is organized as a training place for Bachelor and Master level students in providing therapeutic counseling, educational services, community outreach, case management, improving access to existing services, increasing social awareness, prevention & intervention services to at-risk children, adolescents, women in crisis, the elderly population and families, The corporation will address the problems of domestic violence, mental health, gang involvement, substance abuse, poor academic achievement, decaying family relationships, elder care, and etc. The corporation will address these issues and others through the development of programs, and building of community partnerships designed to increase academic performance in school, increase gang & drug awareness, provide services for domestic violence and substance abuse, home health and congregate meals for the elderly with a focus on family preservation and self sufficiency.
- B. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are limited to those permitted under Section 501©(3) of the Internal Revenue Code.
- C. This corporation will exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- D. This corporation shall not engage in any action which is not permitted to be carried on by inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to those people for services rendered, and to make payment and distributions in furtherance of its stated purposes.
