The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is **FAMILY RAINBOW MINISTRY, INC.**

ARTICLE II

DURATION AND BEGINNING OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence as of the filing of the Articles of Incorporation.

ARTICLE III

STATEMENT OF CORPORATE NATURE

This is a nonprofit corporation organized solely for general religious and charitable purposes pursuant to the Florida Corporations Not for Profit Law set forth in Part 1 of Chapter 617 of the Florida Statutes.

ARTICLE IV

PURPOSES

The purposes for which this corporation is formed are to promote co-operation in all matters of charitable interest to the general public of the Florida region and to help single head of households with children to develop and increase civic interest and pride.

ARTICLE V

This corporation shall have a perpetual existence.

ARTICLE VI

INITIAL BOARD OF DIRECTORS

The corporation shall have THREE (3) initial directors. The number of directors may be increased or decreased from time to time in the manner provided in the bylaws of the corporation provided it is never less than three. The name and street address of the initial directors are:

ARTICLE VIII
BYLAWS

Subject to the limitations contained in the bylaws, and any limitations set forth in the Corporations Not For Profit law of Florida, concerning corporation action that must be authorized or approved by the members of the corporation, bylaws of this corporation may be made, altered, rescinded, added to, or new bylaws may be adopted, either by a resolution of the board of trustees or by following the procedure set forth therefor in the bylaws.

ARTICLE IX
DEDICATION OF ASSETS

The property of this corporation is irrevocably dedicated to religious, educational and charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

ARTICLE X

DISTRIBUTION OF ASSETS

Upon the dissolution of winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational and charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.

ARTICLE XI

AMENDMENT OF ARTICLES

Amendments to these articles of incorporation may be proposed by a resolution adopted by the board of trustees and presented to a quorum of members for their vote.

Amendments may be adopted by the vote of 51% of a quorum of members of the corporation.
