Articles Of Incorporation
Of
Project Youth Care Inc.

Article I

The name of the Corporation is Project Youth Care Inc.

Article II

Project Youth Care Inc.

Article III

The purpose of the Corporation is as follows

A. This Corporation is a Not-For-Profit Corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The Specific purpose of the Corporation is as follows.

1. To provide Shelter and Care for Underprivileged and At Risk low income Youth in the Gainesville Community. To provide food, clothing, adequate housing and special programs for literacy and slow learners and readers.
2. To develop a support program addressing juvenile delinquency, crime prevention, mentoring, drug abuses and character building through recreation and competitive sports.
3. To provide special services for Foster children, child care, Day care and Senior Adult care.
4. To exercise all rights and powers conferred by the Laws of the State of Florida upon Non-Profit Corporations.

Non-Profit Corporations.

- B. Notwithstanding any other provision at the Articles, the purpose for which the Corporation is organized are exclusively religious, charitable, scientific, literacy, and educational within the meaning of Section 501 C 3 of the Internal Revenue Code of the 1986 or the corresponding provision of any future US Revenue Law.
- C. Provide however that the Corporation shall not engage in any action which is not Permitted to be carried on by Non-Profit Corporation under the Internal Revenue Code and no part of the Net Earnings of the Corporation shall inure to the benefit of Or be distributed to it's members, directors, or officers, buy the corporation shall be Authorized and empowered to pay reasonable compensation to those people for Services rendered and to make payments and distribution in furtherance of it's stated Purposes.

Article IV
Members

The Corporation shall have voting members, who shall be elected (and may be removed) by the voting members and who shall have all the rights and privileges of members of the Corporation. The By-laws may provide for non-voting members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the By-laws, but who shall not have the right to vote. Directors are elected in accordance with bylaws.

Having been named as Registered agent and to accept service of process for the above stated Corporation at the place designated in this Certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and I am familiar with and accept the obligations of my position as Registered agent.
